
Water Utilities Committee

Ernie Henrie, Water Utilities Committee (WUC) Chair, and his committee are researching ways to improve the Wilderness Rim Water System Rules and Regulations. Changes will focus on improving efficiency, effectiveness and use of electronic billing and payment options. Also, the contract with Sallal Water Association is due for review before the end of the year.

Any member of WRA is eligible to participate in these review processes by attending the committee meetings. See the schedule on page two.

Remember that it is your responsibility to keep your water meter clear so it can be read. If this is not done, your water usage will be estimated, likely resulting in a higher water bill. If WRA has to clear your meter for you, there will be a minimum \$100 charge. If you need help locating or clearing your meter, please contact the WRA Office by email or telephone.



Noxious Knotweed in the Rim

King County will again be treating Japanese Knotweed on county and corporate property in Wilderness Rim. If you suspect that Knotweed is growing on your property, you must take approved steps to control it. Please do not cut it, mow it, or burn it as this will just encourage further outbreaks of this noxious weed. To learn more visit:

Avoid Late Charges and Fees



Many people are charged late fees for not paying their WRA account on time. All payments must be received by WRA by the printed due date. **This month the due date for payments is Monday, October 27**. This change allows a few more days to work on collecting late accounts. Late notices, following up on those accounts and providing shut-off notices is unavoidable as long as members don't pay until threatened with water shut-off. The WRA Board will soon review recovering this cost to the Association via a \$20 charge to provide a shut-off notice. If you cannot make your payment on time, please contact the office to make arrangements before it is late. Just call the office at 425-888-0087 or email office@wildernessrim.org to avoid \$15 or \$30 in late charges, a possible fee for a shut-off notice, and the \$100 shut-off fee.


For those few of you who are sending your payments to any other utility (including Sallal Water Association) — you, too, will be charged late charges if your payment does not reach WRA by the printed due date on your invoice.

Barking Dogs Could Cost up to \$1000 Fine

King County Animal Control may levy hundreds of dollars in fines against dog owners who do not control their pets. No improvement has been noted since the last newsletter asking dog owners to take steps to train and control their barking dogs. Any dog not under an owner's control at all times are increasingly a concern in the Rim. If you allow your dog to be an offender —
