\$49.85 minimum charge for the first 200 cubic feet used (0 - 200)
\$4.16 per 100 cubic feet for the next 900 cubic feet used (201 - 1000)
\$4.69 per 100 cubic feet for the next 400 cubic feet used (1001 - 1500)
\$6.46 per 100 cubic feet for the next 700 cubic feet used (1501 - 2000)
\$8.80 per 100 cubic feet for the next 300 cubic feet used (2001 - 2500)
\$15.30 per 100 cubic feet for the next 500 cubic feet used (2501 - 3000)
\$26.36 per 100 cubic feet for usage above 3000 cubic feet
